Limited Warranty:

Warranties are valid from the date of purchase to the original purchaser and non-transferrable. Proof of purchase (original sales receipt including purchase date) is required. Validity of this warranty is subject to the discretion of Goliath Custom Furniture. Inspection and photos of damage may be required. Shipping of warranted item to Goliath Custom Furniture, its representative or dealer is the original purchaser's responsibility. Return freight is covered for the first year and only within the Continental U.S. All decisions on whether to repair, replace, and/or refinish are at the sole discretion of Goliath Custom Furniture.

Materials, Upholstery, Workmanship and Craftsmanship – One Year

We warranty that goods are free from defects in materials, upholstery work, workmanship and craftsmanship for one year from the date of purchase on all products not addressed below or excluded. We will replace, repair or refinish the effected product in the original color and style, if available, or in a similar color and style if the original has been discontinued.

Extruded Aluminum Frame – Seven Years

If the extruded aluminum furniture frame fails structurally (i.e. broken frame or welds) within 7 years from the date of purchase, we will replace, repair or refinish the frame in the original color and style, if available, or in a similar color and style if the original has been discontinued.

Paint Finish – One Year

If finish blisters or peels within one year from the date of purchase, Goliath will repair or refinish the frame in the original color and style, if available, or in a similar color and style if the original has been discontinued.

Vinyl Strap – One Year

If a strap breaks within one year from the date of purchase, a replacement strap will be sent directly to you, upon receipt of the broken strap, in the original color and style, if available, or in a similar color and style if the original has been discontinued. If a strap becomes faded or mildewed within two years from the date of purchase, a replacement strap will be sent directly to you, upon receipt of the faded or mildewed strap, in the original color and style, if available, or in a similar color and style if the original has been discontinued.

Fabric on Cushions, Slings and Umbrellas – One Year

If the fabric on a cushion, sling or umbrella tears, mildews or fades excessively within one year from the date of purchase, we will repair or replace the fabric in the original color and pattern if available, or in a similar color and pattern if the original has been discontinued.

Umbrellas and Umbrella Bases – One Year

If an umbrella or umbrella base fails structurally within one year from the date of purchase, we will, at factory option, repair or replace the umbrella or umbrella base, in the original color and style if available, or in a similar color and style if the original has been discontinued. Fabric umbrellas are constructed from the finest commercial material. Due to severe weather to which umbrellas may be subjected, warranty does not apply.

Woven Components – One Year

If a woven component fails structurally (i.e. broken frame, welds, or resin), or if the weave unravels or fades excessively within one year from the date of purchase, we will replace, repair or refinish the product in the original color and style, if available, or in a similar color and style if the original has been discontinued.

Composite Table Tops – One Year

If a composite table top or copper top fails structurally within one from the date of purchase, we will, at factory option, repair or replace the table top, in the original color and style if available, or in a similar color and style if the original has been discontinued. Some of the table tops have painted decorations which may fade when exposed to direct sunlight. This fading is excluded from the warranty. See other exclusions below.

Cast Aluminum Tops – Two Years

If a cast aluminum top fails structurally within two years from the date of purchase, we will, at factory option, repair or replace the table top, in the original color and style if available, or in a similar color and style if the original has been discontinued. Some of the table tops have painted decorations which may fade when exposed to direct sunlight. This fading is excluded from the warranty. See other exclusions below.

Component Parts – One Year

If a component part (glides, bolts, wheels, etc.) fails due to manufacturing defects within one year from the date of purchase, we will, at factory option, repair or replace the part, in the original color and style if available, or in a similar color and style if the original has been discontinued.

Exclusions - Warranties become null and void in the event of damage to the product resulting from any of the following:

- Failure, damage or breakage due to unreasonable, unanticipated, abuse use or misuse
- Unauthorized repairs - Repair, alteration or modification of the product by anyone other than Goliath Custom Furniture or authorized representatives or dealer thereof
- Failure, damage or breakage resulting from accidents, acts of nature (including but not limited to extreme temperatures, wind, hail and lightning) or force majeure
- Normal color fading of fabrics, vinyls, or woven materials caused by exposure to the sun and weather
- Minor variations in color and texture finishes
- Changes in wood color due to natural aging of the wood
- Vandalism
- Furniture is not designed for in-pool use — Voids Warranty
- Failure, damage or breakage caused by lack of reasonable or necessary care, maintenance and/or storage
- Failure, damage or breakage caused by improper packing or occurring during shipment of product to Goliath Custom Furniture, its authorized representatives or dealer for authorized repair or replacement
- All customer supplied/owned materials are excluded from our warranties
- Return freight after one year or outside of the continental U.S.
